Initially I filled out an USPS international express form. When I got to the counter, the rep said I needed a different form. He handed me a global express label to fill out.

I looked at it carefully. It's all about commercial products, which is NOT what I want. Filled it out and when I returned, I commented that the form was incorrect. The contents were *not* commercial. That this is art on loan for a show. He stated this was indeed the correct form.

Ok, I say, how about the 'value'. I wrote \$300 because I'd like to insure it for \$300, not that this is the value though. You can't insure it, he said. I was unsure and nervous. Even having hot flashes. None of this felt right, not like when I send packages to Germany.

And it is very difficult for us to pay for it right now. We asked some advices to some consultancy but we are not sure about the system. We are so busy because of the openning. There are 63 artists in the exhibition and 150 art pieces too. Maybe you can imagine how much a big chaos going on right now. We will let you know about the news. Sorry for that. Really you know Turkey is not an easy country, especially these days..

dear bahar,

I've reflected on the unfortunate circumstances concerning my artwork for the show. the problem lies with the customs form the u.s. postmaster had me fill out. i specifically stated this is NON-commercial; that this is work i made for an art show; that this is NO merchandise; that this was a LOAN to you and your gallery; that the work would return to me. no duty should be charged since no money has changed hands.

please reject the packet and ask that it be returned to sender.

you may freely send this letter on to the Turkish duty office.

Hello Helga,

I'm Merve, Bahar's sister. I talked to the lady who works on the shipping company. She told me that you have to request back your art piece from FEDEX. We couldn't do anything legally and officially. So sorry but you have to deal this situation with FEDEX. You need to write an email or make a call them and tell about the situation. Tell them you want it back and there is a mistake about the receiver name-adress. We can't do anything because there is no official company called "Park Art" and its really horrible system on our customs. Let us know if you need anything, or Fedex wants us to do..

I call the 800 number at USPS global shipping. I explain the situation to the woman. She's sweet and understanding. She asks whether I'd been informed there'd be duties to be charged. No, the guy at the post office said no such thing. I told him I wanted to insure the work, that it was art I made for a show; he said that couldn't be insured. OK, she says, I'll affix a note that it be returned to you.

Thank you.

July 18

Called USPS again about my piece. Thought it would be returned by now.

Well hello. USPS said they couldn't do anything any more. Since it arrived at its destination it's now in the hands of FEDEX International since they're the carrier.

She connected me with FEDEX. The first person I spoke with said I'd need to pay return shipping before they could send it. How much is that? Let me see... \$175. What!? What do you mean? That's more than what it cost to send. Between shipping and the cost of photography I could have personally delivered the work! There's no way I can afford to pay that. Then the person responds, hold on, there's a note attached. Says shipping will be charged to an account. Whose account is that? I don't know she says. Let me connect you with someone who does.

After a few minutes someone else comes on the line. No, you don't need to pay. Billing goes to an account. Whose account? Ours. Great, I say. So, how does this happen? Well, the woman says, it also says they require a letter requesting release of the packet from Turkish Customs. Who needs to write this? I'd think it is FEDEX since it's our responsibility. Let me check to confirm.

After a bit she returns. She still doesn't know, but she'll look into it. Can she call back tomorrow? Sure, I say.

Nothing.

I've been waylaid with Open Studios. An utterly frustrating two weeks. After last night's meeting things finally seem to be figuring themselves out. Feel like I'm decompressing, feeling liberated.

Time to turn to Kara Lale.

Call FEDEX International. It takes a while to get through, my tracking number has become kind of non-existent but, finally, yes.

Yes, says the guy at FEDEX, they've gotten an account number approved for the charges. And whose account is that? The Post Office. They've provided an account number. The Post Office, the USPS? You think they will pay this? (OMG, I think to myself, I may never get this back.) They're bankrupt. What are the charges? There's a brokerage and storage fee. Right now it's considered abandoned. If you abandon it, there's no charge.

No way, if this weren't sad, it'd be funny, I say. This belongs to me and I'd like to have it back. It was all a mistake.

He says they'll need a need a letter requesting release of the package. Who's to write this letter? Since you're the sender, that would be you. Ok, not the shipper but me? Yes. To whom do I send this? Is there an email address? Yes, you can write to 879416@fedex.comwe. .comwe? I repeat questioningly. Yes, .comwe. Explain why it is you want the package returned.

I write my letter, cc myself and click send. Oops. It bounces. Hmmm. I try the variation <u>879416@fedex.com.we</u>. Also bounces.

Back to FEDEX. This time I speak with Brandon. Sounds sleepy but friendly. He provides the correct address 879416@fedex.com!

Hey, I say, can you tell me specifically what kinds of charges are attached to this?

He says customs fees. There's

- Brokerage and warehouse fee \$75
- Terminal fee \$85
- Export warehouse fee \$63
- Government Stamp fee \$32
- Freight TBD

But, there are no charges if you abandon it.

No way. I laugh, say if this were funny, OK, but I feel like crying. Is there any way you can send me this info? I'd like to make art about it. No, he responds. I tell him this belongs to me. It's my artwork. Sorry for sounding upset, it's not about you.

Thank you, have a good day.

I cut and paste my original letter into a new mail, addressing it to the correct place. Maybe.

On July 1, 2013, I shipped a 7oz. packet to a small gallery in Istanbul, Turkey. The package contains artwork made by me; it was sent as a loan for a show, and intended to return to me, its owner. This small packet is currently held at Turkish Customs Office.

At time of shipping no person indicated that either receiver or sender would be responsible for custom's duties imposed by Turkey. Nor did we know this could happen. On July 9, I requested the package be returned to me. After repeated phone calls with fedex since that time, I understand you require a letter requesting release of my packet.

I hereby request Turkish Customs in Istanbul to release my package and return it to me, its owner. I further request no charge be incurred to any party as all transpired in ignorance. I request, too, that this process be expedited since the art is scheduled to hang in a show in Boston in September, 2013.

As a frequent traveller to and a friend of Turkey, I am disheartened by the current situation. I hope it will be resolved.

September 23

Mail from FEDEX arrived today. It's a duty and tax invoice. It also includes two pages of rules for why one pays duties.

Duties, Tax, Customs, and other fun stuff totals \$210.68. Hey, it also says 'Other discounts may apply.'

So much for believing anything anyone says. Feel like some fool.

January 29

Mail from FEDEX arrived today. Dated January 26. Still another duty and tax invoice.

March 21

Mail from a creditor collecting for FEDEX. In addition to the \$210.68, they've added on a collection fee of \$29.50 for a grand total of \$240.18. Interesting how quickly I can rack up charges without doing anything. Wish my work could sell similarly.

March 25

This morning I call FEDEX.

Trina transfers me to Sheena in the Tax and Duties Department.

I explain my story to her, that I've documented it since the beginning. Sheena listens and then explains to me that the only thing anyone ever said was that shipping would be waived, not the taxes and duties; that they're only charging for taxes and duties for which one is ALWAYS responsible. I explain that no one even mentioned the possibility of these costs when I shipped the work in July. It is non-commercial and has no commercial value. The cost of sending to Istanbul alone is likely more than I'll ever make in selling the work.

So, she says, the only thing she can do is give me a partial credit for the charges. She can do 50% of \$210.68. That'd be \$105.34. The bill is over 180 days old so you'd have to pay now, there's no payment plan.

Sheena makes the adjustment and transfers me to Courtney in billing. I pay with my cc. Confirmation no. 90805616.
